Interim Domestic Violence & Abuse Strategy

2017-18

1. Introduction

1.1 Background

The Greenwich Domestic Violence and Abuse Strategy was updated to cover the period 2013-17. Whilst Domestic Violence and Abuse (DVA) is a form of Violence Against Women & Girls (VAWG), it was agreed to develop a separate, but closely linked, strategy for this issue. This is because, when compared to other forms of VAWG:

- There is a greater prevalence of male victims.
- There is a far greater volume of recorded offences.
- More research has been carried out and there is a more substantial knowledge base about what needs to be done.
- There is a much greater range of services and arrangements in place to support victims.

A separate VAWG Strategy was subsequently developed, to cover the period 2015-18. The aim is to bring the DVA and VAWG strategies together for 2018-21, in order to do so this refresh of the DVA Strategy has been developed in order to bring the timescales of both strategies in line with each other. This interim strategy follows the same structure of the VAWG Strategy and should be read alongside it, particularly when referencing some of the background information e.g. looking at issues of under-reporting. The refresh will also incorporate new government guidance and legalisation.

1.2 Domestic Violence & Abuse Strategy 2013-17

The DVA Strategy focused on four key strategic aims:

- Protection, reducing re-victimisation and mitigation: helping protect victims and their families, reducing repeat victimisation and mitigating the impact that domestic violence and abuse has on their lives;
- Deploying the powers of the Criminal Justice System and Civil Courts to deal with abusers and further protect victims;
- Preventing domestic violence and abuse from happening in the first place; and
- Tackling social tolerance and blindness of domestic violence and abuse by individuals and organisations.

There were two principles outlined as key to this Strategy:

- Keeping victims and their children safe lies at the heart of action we take to tackle
 domestic violence. Our top priority is the protection of high risk victims and children,
 and particularly reducing the risk of domestic homicides and child death;
- Holding perpetrators responsible for their behaviour. The responsibility for abusive behaviour lies with the person perpetrating it and not with his or her victim; victims must not be blamed for the abuse.

1.3 VAWG Strategy 2015-18

The VAWG Strategy focuses on the following range of serious crime types which are predominantly, but not exclusively, experienced by women and girls:

- Domestic Violence and Abuse
- Sexual Offences
- Stalking
- Female Genital Mutilation
- Crimes Said to be Committed in the Name of 'Honour'
- Forced Marriage
- Prostitution

- Trafficking for Sexual Exploitation In Royal Greenwich, we also include:
- Exploitation of Girls by Gangs

The VAWG Strategy does not include responses to Child Sexual Exploitation but recognises links with the Greenwich Child Sexual Exploitation (CSE) Strategy.

The VAWG strategy being linked to the DVA strategy holds the same four key strategic aims and principles, but emphasises key principles common across most of the eight strands:

- Ensuring that the safeguarding of children and vulnerable adults is at the forefront of any action taken.
- Ensuring that the safety of both victims and professionals is the key consideration.
- Taking all allegations seriously and at no point suggesting that the victim may be responsible for what has happened to them.
- Encouraging victims to report to the police but respecting the wishes of adult women if they do not wish to do so.

The information on each strand of the VAWG Strategy has been turned into fact sheets which are available on the Council's website. The information within this refreshed strategy will also form the basis of a fact sheet to be published in the same way.

1.4 Governance and Delivery Structure

No single agency can effectively tackle DVA/VAWG on its own. Agencies must work together to ensure that their respective roles are clear and their joint response to DVA/VAWG is well co-ordinated.

Several established partnership governance groups have a role in responding to DVA/VAWG in Royal Greenwich. The key partnership governance groups are:

- Safer Greenwich Partnership (SGP)
- Greenwich Safeguarding Children's Board (GSCB)
- Children's Trust Board (CTB)
- Health and Well-Being Board (HWBB)
- Safeguarding Adults Board (SAB)

The SGP has established 'Ending Violence Against Women and Girls' as one of its priorities and develops an annual action plan to deliver the more detailed priorities set out in this strategy. It has also established a Violence Against Women and Girls Strategic Partnership Group. This group is responsible for leading on the community safety aspects of VAWG as well as ensuring strategic coherence between the different partnerships and agencies involved. It also oversees the delivery of the annual VAWG action plan. The GSCB has also chosen VAWG as one of its key priority areas.

There are also a number of multi-agency case panels that look at individual victims or perpetrators.

When a domestic homicide occurs, the SGP holds the statutory responsibility for establishing whether a Domestic Homicide Review (DHR) should be carried out and establishing a review panel. The final report of any DHR is submitted to the Home Office and will also be reviewed by the SGP.

1.5 Monitoring Progress of This Strategy

The development and implementation of this strategy and progress in meeting the annual VAWG action plan will be monitored by the Violence Against Women and Girls Strategic Partnership. Updates will also be provided to the Safer Greenwich Partnership and any issues of concern will be escalated to them. Reports will also be made to the other key strategic partnership boards/groups in the borough.

Police data will be used to monitor the number of reported offences. However, it is important to note that initial work to raise awareness and improve victim confidence means that there is likely to be initial increases in the number of offences reported to the police.

Data from a number of statutory and third sector agencies will also be monitored as they will help to provide a fuller picture of the prevalence of VAWG on the Borough and the impact of any work to reduce it.

2. Domestic Violence & Abuse

2.1 Definition

Physical violence is tangible and its physical and visible elements are harder to ignore whilst other forms of abuse often go unnoticed but can be equally damaging. This strategy takes domestic violence to include all forms of aggressive behaviour in intimate and family relationships, including physical violence, coercive control, psychological intimidation and financial control.

The Home Office Definition of Domestic Violence and Abuse is:

"Any incident or pattern of incidents of controlling, coercive or threatening behaviour, violence or abuse between those aged 16 or over who are or have been intimate partners or family members regardless of gender or sexuality. This can encompass but is not limited to the following types of abuse:

- physical
- sexual
- psychological
- emotional
- financial

Controlling behaviour is: a range of acts designed to make a person subordinate and/or dependent by isolating them from sources of support, exploiting their resources and capacities for personal gain, depriving them of the means needed for independence, resistance and escape and regulating their everyday behaviour.

Coercive behaviour is: an act or a pattern of acts of assault, threats, humiliation and intimidation or other abuse that is used to harm, punish, or frighten their victim."

A coercive or controlling behaviour offence came into force in December 2015. It carries a maximum 5 years' imprisonment, a fine or both. Victims who experience coercive and controlling behaviour that stops short of serious physical violence, but amounts to extreme psychological and emotional abuse, can bring their perpetrators to justice. The offence closes a gap in the law around patterns of controlling or coercive behaviour that occurs during a relationship between intimate partners, former partners who still live together or family members

2.2 Local and National Picture

Local

In 2015/16, there was a total of 2,993 Domestic Offences recorded on the borough. This was an increase of 10.4% on the 2,710 offences recorded the previous year. The Sanctioned Detection rate for Domestic Offences in 2015/16 was 32.1%, a reduction on the previous year's rate of 35.9%.

In 2015/16, there was a total of 914 Domestic Offences With Injury recorded on the borough. This was a reduction of 0.8% on the 921 offences recorded the previous year. The Sanctioned Detection rate for Domestic Offences With Injury in 2015/16 was 40.8%, a reduction on the previous year's rate of 43.3%.

The last review into all VAWG offences took place in November 2014, looking at data from 1st October 2013 to 30th September 2014. The review found that:

- Domestic Offences accounted for 35.6% of all Violence Against the Person.
- 71.5% of Domestic Offences were Violence Against The Person.

- 33.7% involved alcohol and 15.0% involved drugs.
- The primary hotspot was Woolwich Common, with secondary hotspots in Greenwich West, Woolwich Town Centre, Woolwich Dockyard and Glyndon.
- There were increases over the summer months, with peaks in the evenings/early mornings, particularly over weekends, with an additional peak at midday.
- 77% of victims were female
- 80% of suspects were male.
- Most victims and offenders were aged 20-29 years.
- Most victims and offenders were White European.

This review will be carried out again in order to inform the new VAWG Strategy for 2018-21.

National

In 2015/16, there was a total of 74,112 Domestic Offences recorded on the borough. This was an increase of 10.6% on the 67,002 offences recorded the previous year. The Sanctioned Detection rate for Domestic Offences in 2015/16 was 32.6%, a reduction on the previous year's rate of 36.7%. Royal Greenwich was ranked 4th out of the 32 London boroughs (where 1st is the borough with the highest number of offences).

In 2015/16, there was a total of 23,748 Domestic Offences With Injury recorded on the borough. This was an increase of 4.6% on the 22,712 offences recorded the previous year. The Sanctioned Detection rate for Domestic Offences With Injury in 2015/16 was 41.2%, a reduction on the previous year's rate of 45.4%. Royal Greenwich was ranked 9th out of the 32 London boroughs (where 1st is the borough with the highest number of offences).

2.3 Key Drivers and Risk Factors

We need to understand the causes of domestic violence if we are to tackle it effectively. There are a number of key drivers in cases of DVA that may or may not be present in all cases:

- Control and power over the victim by the perpetrator.
- Drug and alcohol use.
- · Cultural attitudes.
- Poverty and the stress it causes.
- High levels of stress and particularly stressful life transitions such as pregnancy and early years parenting.
- Psychological vulnerabilities and patterns of behaviour rooted in past experiences and particularly childhood experiences (such as insecurity, jealousy and dysfunctional ways of resolving conflict) of victims and perpetrators.
- Dynamics that play out between two people in an abusive relationship; they do not act
 in isolation from each other and in some instances both partners may exert some
 influence over the abusive patterns that develop and continue to play out.

All this indicates that DVA is a complex issue that requires a nuanced understanding of the problem and requires sophisticated responses tailored to the needs and circumstances of each perpetrator and victim. Perpetrators abuse for different reasons, victims stay for different reasons and sometimes there is not even a clear perpetrator and victim. There are some commonalities and patterns, but no 'one size fits all'.

2.4 Key Principles

The same key principles will inform our interventions to tackle domestic violence and abuse as laid out in the DVA Strategy 2015-18:

- Protection, reducing re-victimisation and mitigation: helping protect victims and their families, reducing repeat victimisation and mitigating the impact that domestic violence and abuse has on their lives;
- Deploying the powers of the Criminal Justice System and Civil Courts to deal with abusers and further protect victims;
- Preventing domestic violence and abuse from happening in the first place; and
- Tackling social tolerance and blindness of domestic violence and abuse by individuals and organisations.

2.5 Ambitions

Our ambitions for 2017-18 are to:

- Strengthen Adult Safeguarding approaches to victims of DVA who are vulnerable, inline with the introduction of the Care Act 2014 and Safe Lives recommendations.
- Carry out research into available perpetrator programmes to establish their effectiveness and make recommendations for local commissioning.
- Continue to promote positive relationships between young people through work in schools and youth hubs.
- Hold MARAC training for frontline staff to enable them to make effective and appropriate referrals.
- Increase knowledge of the new law around coercive control amongst professionals and public.
- Implement the IRIS project to train GPs about Domestic Abuse and improve referrals (subject to funding being approved).
- Research new approaches to tackling Domestic Abuse for inclusion in the new VAWG Strategy.
- Seek new funding to increase effective activity to tackle low-risk cases of DVA and preventing DVA from happening in the first place.
