- (b) I understand that any permit issued to me by the Royal Borough is in respect of the said address and that such issue and any subsequent issue of a permit is conditional upon my surrendering to the Royal Borough the said permit on the happening of one of the following events:
- (i) I cease to be a resident as defined in the order.
 - (ii) Upon the issue to me of a duplicate permit.
 - (iii) The said permit ceasing to be valid at the expiration of the period specified thereon.
- (c) I undertake to inform the Royal Borough immediately any of the events specified have occurred.
- (d) I declare that all the information I have given in this application is correct.

N.B. The onus to renew a permit rests with the applicant.

It is an offence under the Vehicle (Excise) Act 1962 (section 7) to park or keep any mechanically propelled vehicle on a public road if the vehicle is unlicensed, and it is an offence under the Road Vehicles (Registration and Licensing) Regulations 1964 (Section 20) to keep such a vehicle on a public road if the licence is not displayed in the vehicle.

Applicants are reminded that the Royal Borough may require an applicant (or permit holder) to produce to an officer of the Royal Borough such evidence in respect of an application (or permit already granted) as they may reasonably call for to verify particulars supplied. The Royal Borough may withdraw a permit if it appears to them that any of the particulars supplied are untrue or false.
