The applicant wishes to apply as follows:

- Films, Live & Recorded Music, Dance, and Activities Similar to Music & Dance (e.g. parkour, etc) between 12:00 noon and 22:00 hours, on **Thursday 21st * & Friday 22nd 2025**. *There is no application for the sale & supply of alcohol.*

Thursday 21st August 2025 will be set aside as a Dress Rehearsal day. Whilst rehearsals are not considered a licensable activity in and of themselves, **the applicant seeks the premises licence to cover that day (as well as the formal performance day of Friday 22nd) as it is likely such rehearsals will unintentionally attract an audience, however small and brief, and they wish to avoid the potential for any breaches of the Licensing Act 2003, however inadvertent.*

The event itself, which involves parkour performances, is described by GDIF as follows:

“Above and Beyond, by French company Lezards Bleus, is a bespoke, site-specific promenade piece that will traverse Woolwich Town Centre, taking in sites and architecture across General Gordon Square, Powis Street, and the newly regenerated Beresford Square. Eight performers will use a combination of climbing and dance techniques to form spectacular choreography. Music will be by renowned composer Roma Yagnik and performed by the Citizens of the World Choir, a choir of migrant and refugee singers.”
