Despite the hours sought for LNR, the premises will be shut when the station is closed to the general public – usually from approximately midnight until 5:00am – except in circumstances when the following offered condition can apply: *“Beyond usual operating hours for Woolwich Arsenal railway station, the premises will remain open for Late Night Refreshment for members of the public or maintenance rail workers in exceptional circumstances, or if requested to do so by the police or station operators.”* Throughout the night, the station remains open to railway employees for the purposes of through (non-stopping) trains, maintenance works, the shunting of rail-stock, and so forth.
