
2011 Census Key Statistics

This summary provides a series of Key Statistics that have emerged as part of an in-depth analysis of the 2011 Census for the Royal Borough of Greenwich, across the following categories:

- 1 Population & Demography;
- 2 Housing;
- 3 Health & Education; and
- 4 Socio Economics

The maps within this summary display Key Statistics information at Lower Super Output Area (LSOA) level. These are a series of aggregated Output Areas (OAs)1, and on average consist of 1,780 people and 707 households. There are 151 LSOAs within the Royal Borough of Greenwich, with each ward comprised of on average nine LSOAs. This however varies across the Royal Borough as areas with larger population densities (i.e. Woolwich) have more OAs, and subsequently more LSOAs within the associated ward.

¹ Output Areas (OAs) are the smallest statistical geography at which data is collected. There are 809 output areas within the Royal Borough of Greenwich, consisting of on average 315 residents and 125 households. These tend to be shaped around established communities and constrained by obvious boundaries, such as major roads, rivers and other physical infrastructure.



Population & Demography

Population Age

According to the 2011 Census, the Royal Borough of Greenwich has a total population of 254,557. This is comprised of 249,991 people living in households and 4,566 living in communal establishments. This figure does not take into account the 2,542 students living away from home.

Of the total population, 24.1% are aged 0-17 making it comparatively younger than London (22.2%) and the national (21.4%) averages. 173,047 people are aged 16-64 (working age) accounting for 68% of the total population, compared to the figure of 69.1% for London and 64.8% nationally.




Figure 1.2: Percentage of Children aged 0 to 17 by LSOA



Within the Royal Borough, the younger aged 0-17 population are spatially concentrated in Thamesmead Moorings and Abbey Wood, with a cluster of high concentration also evident in Woolwich Common. The wards with the lowest proportion of children are Eltham South, Peninsula, Greenwich West and Blackheath Westcombe wards.




Figure 1.3: Percentage of Children aged 5 and Under by LSOA



The highest concentration of children aged five and under can be seen at the heart of the Royal Borough in Woolwich Common and within Thamesmead Moorings. Conversely, some of the lowest proportions are seen in the south and centre of the Royal Borough, particularly Eltham North, Eltham South and Coldharbour & New Eltham.




Figure 1.4: Percentage Working Age Population (aged 16-64) by LSOA



The highest concentrations of working age population are seen in Greenwich West (74.9%), Peninsula (74.8%) and also in the wards of Woolwich Riverside and Glyndon (both 70.1%). This compares to the Royal Borough average of 68%. The wards with the lowest proportions of working age population however, are Abbey Wood (63.6%), Middle Park & Sutcliffe (63.8%) and Coldharbour & New Eltham (64.5%).

The highest spatial concentrations of residents aged 65+ tend to be located in the south of the Royal Borough, particularly in the wards of Eltham North, Eltham South and Coldharbour & New Eltham. However, there are also clusters located in the north-west of the Royal Borough and in Middle Park & Sutcliffe. The wards with the lowest population aged 65+ are situated in Thamesmead Moorings (4.7%), Woolwich Common (5.9%) and Woolwich Riverside (6.2%).



Ethnic Group

2011 Census data shows that the Black and Minority Ethnic (BME)2 population of the Royal Borough of Greenwich accounts for 47.7% of the total population (121,427 people), compared to the London average of 55.1% and the national average of 20.2%.



The geospatial distribution of the BME population within the Royal Borough is concentrated within Thamesmead Moorings (66.7%), Woolwich Common (65.6%), Glyndon (64.2%) and Plumstead (63.2%), whereas the highest White British populations are concentrated in Eltham North (80.8%), Eltham South (75%) and Coldharbour & New Eltham (74%). The Royal Borough has the 9th highest proportion of White British population across all 33 London boroughs with 52.3%.



Country/Continent of Birth

When comparing the country of birth of residents across all London boroughs, the Royal Borough of Greenwich has the following characteristics, as a proportion of total population:

- The highest proportion of Nigerians accounting for 5.1% (13,013 people);
- The 3rd highest proportion of Other South Asians with 5,291 people (2.1%);
- The 4th highest proportion Zimbabweans (0.4%) with 962 people; and
- The 5th highest proportion of Lithuanians with 1,979 people, accounting for 0.8%.

Housing

According to the 2011 Census, there are a total of 103,827 households within the Royal Borough. Of this, 101,045 are homes to residents and 2,782 are likely to be second homes or holiday accommodation. This gives a household occupation rate of 97.3% across the Royal Borough, with the Coldharbour & New Eltham ward having the highest occupation rate with 98.9%, whilst Woolwich Common has the lowest rate with 95%.

In terms of average household sizes3, the Plumstead ward is ranked the highest with 2.85, whilst Thamesmead Moorings (2.84) and Woolwich Common (2.75) also have larger household sizes. Wards with the lowest average household sizes are Blackheath Westcombe (2.12), Peninsula (2.26) and Greenwich West (2.33), all of which are located in the north-west of the Royal Borough. These figures compare to the Royal Borough average of 2.52, which is slightly larger than the London (2.50) and national (2.40) averages.


Overcrowded Households

Overcrowding can be measured by considering the number of households with a bedroom occupancy rating of -1 or less 4. Within the Royal Borough, this applies to 11,247 homes which accounts for 11.1%. This is lower than the London average (11.6%) though more than double the national average (4.8%).

³ Average household sizes are calculated by diving the population by the number of households.

⁴ An occupancy rating of -1 implies that a household has one fewer bedroom than required, whereas +1 implies that they have one more bedroom than the standard requirement.

The wards with the highest overcrowded households are located in Woolwich Common (18.8%); Glyndon (18.3%); Plumstead (17.6%); Thamesmead Moorings (15.8%) and Woolwich Riverside (15.3%). This compares to the Royal Borough average of 11.1%. Conversely, the wards of Eltham North (3.8%); Blackheath Westcombe (5%); Coldharbour & New Eltham (6.1%); Eltham South (6.2%) and Middle Park & Sutcliffe (8.1%) have the lowest overcrowding rate across the Royal Borough.



Household Tenure

Of the 101,045 homes within the Royal Borough, almost one-fifth (19.8%) are private rented while over one-third (34.3%) are social rented properties.

The wards with the highest proportion of private homes (owner occupied and private rented) are in Eltham North (81.5%), Shooters Hill (78.7%) and Blackheath Westcombe (75.4%). Eltham North has the highest proportion of owner occupied homes (73.1%). In terms of affordable housing (intermediate, social rented and other social rented) the highest proportions are found in Woolwich Riverside (54.6%), Woolwich Common (52.3%) and Eltham West (45.3%) wards.

⁵ Intermediate housing is homes for sale and rent provided at a cost above social rent, but below market levels subject to Affordable Housing criteria. These can include shared equity (shared ownership and equity loans), other low cost homes for sale and intermediate rent, but not affordable rented housing.

Household Composition

One person households account for almost one-third of total households (32%) within the Royal Borough. Lone pensioner households account for 9.3% of households, which is 0.3% lower than the London level and 3.1% lower than the national average. The Royal Borough also has a higher lone parent household rate of 14.5% when compared to 12.7% across London and 10.6% nationally.



The wards of Abbey Wood (19.7%), Thamesmead Moorings (19.5%) and Woolwich Common (18.8%) have the highest proportions of lone parent households. The wards with the lowest proportion of lone parent households are Blackheath Westcombe (6.5%), Eltham North (9.1%) and Peninsula (10.5%).



Health & Education

General Health

83.1% of the Royal Borough's population are stated as having either a good or very good level of health, compared to 83.8% at the London level and 81.4% at the national level. Conversely, the 5.4% of the Royal Borough's population believe they have either a bad or very bad level of health, compared to 5% for London and 5.5% nationally.

Figure 3.1: Percentage of Residents with 'Daily Activities Limited a Lot' by LSOA



Figure 3.1 shows the spatial concentrations of residents who stated they had a long-term health problem or disabilities that limited their day-to-day activities, and has lasted, or is expected to last, at least 12 months. This includes problems that are related to old age.

The wards with the highest recorded proportions of residents with a limiting condition were Eltham West (10.1%), Coldharbour & New Eltham (9.1%) and Middle Park & Sutcliffe (9.1%). However, the wards with the lowest proportions of residents with a limiting condition, and therefore those with the highest physical ability to undertake day-to-day activities are Greenwich West (88.9%), Thamesmead Moorings (88.2%) and Peninsula (87.1%).

A person is a provider of unpaid care if they look after or give help or support to family members, friends, neighbours or others because of long-term physical or mental ill health or disability, or problems related to old age.

Of the 22,014 residents across the Royal Borough who provide unpaid care, Figure 3.2 shows the spatial distribution of the proportion of those who provide 50+ hours. From this it can be seen that the wards of Eltham West (32.3%), Kidbrooke with Hornfair (28.6%) and Middle Park & Sutcliffe (27.6%) are home to the highest proportion of residents providing 50+ hours per week unpaid care.



Education & Qualifications


Approximately one-fifth (20.6%) of the Royal Borough's population have no qualifications, which is 3% higher than the London level though 1.9% lower than the national average. The Royal Borough has a 0.3% higher proportion of people on apprenticeship schemes than the London figure, though 1.7% lower than the national average. One-third (33.2%) of the Royal Borough population have achieved Level 4+ qualifications.

A higher concentration of residents with Level 4+ qualifications can be seen throughout the borough. The wards with the highest qualifications attained of Level 4+ are Blackheath Westcombe (57.5%), Greenwich West (49.9%) and Peninsula (49.5%). Proportionately, these wards also have the lowest corresponding rates of population with no qualifications.

File Hymber

The wards with the highest proportion of no qualifications are located in the west of the Royal Borough in Eltham West (30.8%), Middle Park & Sutcliffe (25.5%) and Coldharbour & New Eltham (25.4%).

Socio Economics

National Statistics Socio-Economic Classifications (NS-SeC)

Almost one-third (31.5%) of the Royal Borough's population aged 16-74 fall into the top two NS-SeC categories of Managerial, Administrative and Professional Occupations. This figure compares to 36.3% for London and 31.3% nationally. The Royal Borough has a higher rate of Never Worked and Long-Term Unemployed (9%), which is 0.7% higher than the London rate (8.3%) and 3.4% higher than the national average (5.6%).

In terms of the wards with the highest proportions of residents in Managerial, Administrative and Professional Occupations; Blackheath Westcombe is ranked the highest with 57.8%, followed by Peninsula (46.2%) and Greenwich West (45.3%). The wards with the highest proportion of Never Worked and Long-Term Unemployed are Woolwich Common (13.5%), Glyndon (13.3%) and Thamesmead Moorings (11.6%).

Economic Activity

Economic activity relates to whether or not a person who was aged 16 to 74 was working or looking for work in the week before Census. Rather than a simple indicator of whether or not someone was currently in employment, it provides a measure of whether or not a person was an active participant in the labour market.


A person's economic activity is derived from their 'Activity Last Week'. This is an indicator of their status or availability for employment - whether employed, actively looking for work, waiting to start a new job, available to start a new job, or their status if not employed or not seeking employment.

Figure 4.2: Economic Activity





In employment, as an employee or self-employed;



Figure 4.4: Economically inactive population



⁷ A person aged 16+ is classified as economically inactive if, in the week before the Census, they were not in employment but did not meet the criteria to be classified as 'Unemployed'. This includes a person looking for work but not available to start work within two weeks (including anyone not looking for work or unable work). Students who fulfil any of these criteria are also classified as economically inactive. This does not necessarily mean they were in full-time education and excludes students who were working, or in some other way economically active.

The Royal Borough economic activity rate is 70.7%, though this varies between wards. Of this, the wards with the highest levels of economic activity are Peninsula (76.6%), Blackheath Westcombe (75%) and Greenwich West (73%). The wards with the lowest levels of economic inactivity are Eltham South (33.5%), Eltham West (33.4%) and Middle Park & Sutcliffe (32.8%).
