### Origin-Destination Analysis

#### Introduction

The 2011 Census recorded the place of work and method of travel to work of all respondents aged 16 or over. The Special Workplace Statistics dataset provides information on travel to work flows and the characteristics of workers based on where they live (origin) and where they work (destination). This summary note provides an overview of commuting in London and is based on the origin-destination outputs from the 2011 Census.

### Key Findings:

- Only nine London Boroughs see a net employed population increase on a commuting basis;
- 917,068 people commute into the City of London & Westminster from outside of the borough/s accounting for the largest in-commuting population across London;
- The Royal Borough ranks 23<sup>rd</sup> in terms of largest commuting population change with a net commuting population change of -31,268 people (-33.3%); and
- Contextually, the London Borough of Lewisham sees the largest population net change with 110,370 employed residents out-commuting accounting for -51.5%.

## Origin-Destination (i.e. Royal Greenwich residents working in other Local Authorities):

- There was a total of 94,659 employed residents aged 16+ living within the Royal Borough of Greenwich accounting for 3% of London's 3.2 million employed residents;
- 23,759 people both lived and worked in the Royal Borough;
- 70,900 people lived within Royal Greenwich and worked in other local authorities;
- Over 17,000 (18%) residents of Greenwich worked in the City of London & Westminster;
- Approximately 6,900 residents (7.3%) of Greenwich were employed in Tower Hamlets; and
- Over a quarter (25.8%) of Royal Borough residents worked in the London Boroughs of Bexley (6.1%), Lewisham (6.1%), Southwark (6%), Camden (4.1%) and Bromley (3.5%).



# Destination-Origin (i.e. Other Local Authority residents working in Royal Greenwich):

- A total of 63,391 people were employed in the Royal Borough at the time of the 2011 Census;
- Of this, 39,632 people (62.5%) lived outside of the Royal Borough;
- 75.8% (30,027 people) of which lived within other London Boroughs;
- 10,807 people working in the Royal Borough lived in neighbouring Bexley (17%);
- 8.5% (5,360 people) of people employed in Greenwich lived in Lewisham, whilst approximately 3,000 (4.8%) lived in Bromley; and
- 7,124 people (11.2%) lived in the South East region (exc. London) and commuted into Greenwich.
