

## Royal Borough of Greenwich: Annual CIL Rate Summary

In accordance with Regulation 121C of the Community Infrastructure Levy (CIL) Regulations 2010 (as amended), the Royal Borough of Greenwich as a CIL charging authority is issuing this Annual CIL Rate Summary. This Annual CIL rate summary is effective 1 January 2026 to 31 December 2026, and applies to:

- 1) Borough CIL 1 (BCIL1) - adopted 6<sup>th</sup> April 2015 (Table 1), applicable to planning permissions granted prior to 24<sup>th</sup> July 2024.
- 2) Borough CIL 2 (BCIL2) - adopted 24<sup>th</sup> July 2024 (Table 2), applicable to planning permissions granted since 24<sup>th</sup> July 2024.

The CIL is subject to indexation which allows the rates to be increased or decreased keeping the rates responsive to market conditions, reflecting inflation. The Department for Levelling Up, Housing and Communities (DLUHC) developed and introduced an annual index rate, effective following the changes to the CIL Regulations in September 2019. The tables below set out the original CIL charging schedule rates, and the subsequent annual rates taking account of indexation. BCIL1 rates are applicable to CIL liable planning applications approved between 6 April 2015 and 24 July 2024. BCIL2 rates are applicable to CIL liable planning applications approved since 24 July 2024.

Where: **R** is the CIL rate when the Charging Schedule took effect.

**IY** is the index figure for the given calendar year (see table 1a).

**IC** is the index figure for the calendar year in which the Charging Schedule took effect.


