An application for the new grant of a Premises Licence for the above. The applicant wishes to provide the following licensable activities:

- **On-Sale & Supply of Alcohol (No Off-Sales) ancillary to a table meal:** Sunday to Thursday, 12:00 noon until 23:00 hours; Friday & Saturday, 12:00 noon until 23:30 hours – in line with opening times.
- **Late Night Refreshment (provision of hot food &/or hot drink after 11pm):** Friday & Saturday only, 23:00 hours until 23:30. *There shall be no LNR on any other day.*
- **Music shall be played as background only (a non-licensable activity).**

This replaces the applicant’s original Classic Restaurant & Lounge application, which was withdrawn on 25 March 2026. The new application is in significantly reduced terms from the original and proposes to operate as a restaurant only, with alcohol only served with a meal.

132-136 Powis Street was previously licensed in 2014 as a pub, firstly named Powis Arms and subsequently The Volunteer. However, the site was never developed and no trade ever took place there. The licence was deemed lapsed in 2024 after the holding company, Babel Silk Ltd, went into liquidation. Its authorised licensed hours, for on-sales only, were Sunday to Thursday until 23:00 hours, and until midnight Friday & Saturday, with closing times at 23:30 and 00:30 respectively.
